Opis:

Odaberite članak iz novina/stranice na društvenoj mreži o nedavnom događaju/aktualnoj vijesti.

Podijelite razred u grupe od pet ili predstavite članak na plenarnoj sjednici i zamolite sudionike da odgovore na sljedeća pitanja.

- Tko je stvorio ovu poruku? (**Autor**)
- Koje se kreativne tehnike koriste za privlačenje moje pažnje? (**Format**)
- Kako različiti ljudi mogu ovu poruku shvatiti drugačije od mene? (**Publika**)
- Koji stil života, vrijednosti i gledišta su zastupljeni u ovoj poruci ili izostavljeni iz nje? (**Sadržaj**)
- Zašto se šalje ova poruka? (**Svrha**)

Raspravite s cijelom grupom o važnosti ovih pet pitanja.
